

MARYLAND DELAWARE ROCKETRY ASSOCIATION INC. LIABILITY WAIVER, SAFETY CODE AND RISK DISCLOSURE

1. By signing this safety code and liability waiver, I hereby attest that I have read and understand the MDRA Rocketry Safety Code and rules that will apply to all MDRA launch activities.
2. Some of the risks are bodily injury, death from impact to the participants' body, burns, etc.
3. I also agree to report any violations of the Rocketry Safety Code or any unsafe condition to the launch officials.
4. I hereby certify that I have had the necessary experience and training to operate all high power rocket(s) and high power rocket motor(s) which I use at MDRA launches.
5. MDRA launches are not TRA or NAR sponsored. However, you must hold the required high-powered rocket certification from TRA or NAR to use and fly rockets using H or higher impulse motors. All flyers must obtain and/or use rocket motors in compliance with Federal, State and Municipal laws, codes, rules and regulations. All flyers shall be solely responsible for compliance with all Federal, State and Municipal laws, codes, rules and regulations. All flyers will indemnify and hold harmless the Maryland Delaware Rocketry Association, Inc and it's officers from and against any loss, expense, damage or injury caused or occasioned directly or indirectly by their failure to comply with the provisions of the said laws, codes, ordinances, rules, regulations and requirements. I also agree to indemnify and hold harmless the Maryland/Delaware Rocketry

Association and any land owner(s) for my or my guest participation and or actions at this rocket launch. This also includes any bodily injury that I or my guest might incur. I understand that my guests and I are granted permission to enter the launch site property. As provided by the Maryland State Recreational Use Statutes, the land owner does not assure the premises safe for any purpose nor assume responsibility for or incur liability as a result of any injury to person or property caused by an act of omission.

I THE UNDERSIGNED or my guest understand and will at all times conduct ourselves with the understanding that the above stated risks and safety procedures: I also understand that this document may not include all of the potential risks. That even by observing the procedures outlined in the MDRA Safety Code there remains RISKS OF INJURY OR DEATH from ROCKETRY. That the utmost in attention and prudence must be exercised at all times. I assume all of the risks, including, property damage, injury, or even death. I also assume the obligation to exercise the utmost care in pursuit of my activities at all MDRA events. Additionally, I will make no claim against the landowner, MDRA launch officials and/or Board of Directors of MDRA. The Maryland Delaware Rocketry Association, Inc. cannot be held liable for the failure of the participants and or guests to abide by the safety codes, rules, and regulations, etc.
